Notes:

1. It shall be determined that:
 - 1.1. Taxes determined by the law on the oil products produced and sold within the country have been envisaged in the tariffs approved under this resolution;
 - 1.2. Expenses for carrying goods to the stations of "Azerbaijan Railway" CSC in Baku city to be sent, for giving wagons to be loaded, for cleaning and loading them have been considered in the company tariffs;
 - 1.3. Excise and value added tax (VAT), as well as, supply tariffs have been included to the wholesale tariffs of oil products;
 - 1.4. The State Oil Company of Azerbaijan Republic executes sales of oil products by deducting supply tariffs from wholesale tariffs, and supply organizations by wholesale tariffs;
 - 1.5. Wholesale tariffs cover all transporting expenses of oil products, supply tariffs of which have been approved, to retail places operating in the country;
 - 1.6. All legal entities and physical entities engaged in entrepreneurship activity by not establishing legal entity regardless of property form implement wholesale and retail of oil products by the tariffs approved under this resolution.
 - 1.7. In the case that oil products reviewed in this resolution are imported, sales is implemented on the wholesale and retail tariffs approved under this resolution by paying duties and taxes determined by law.
