DECISION approving the pilot schemes form the Vietnam electricity

Article 1 DECISION. Pilot project approval form the Vietnam electricity works according to the model of the parent company-subsidiary, with content as follows: 1. formation of Vietnam electricity, most owned, in which State ownership is dominant, including the 100% state capital business, most businesses owned on the basis of arrangements, reorganized the Vietnam electricity Corporation and its subsidiaries; that level of technology, modern management and high specialization; diversified businesses, including production and sales of electric energy, telecommunications, electric power engineering is the main business; tight cohesion between production, business with science, technology, research and development, and training; core to Vietnam electricity industry rapid development and sustainability, competitiveness and international economic integration effectively.

- 2. The relationship between the parent company in Vietnam with electricity the State owners and subsidiaries, affiliate companies is done according to the laws and regulations in terms of organization and activities of the parent company. The unified Government to manage and organize the implementation of the right, the obligation of the owner for the State electricity Vietnam. The Prime Minister delivered to the ministries, ministerial agencies, government bodies and the Board of Vietnam electricity made some of the owner's rights under current legislation and the Charter the Organization and activities of the parent company.
- 3. The parent company-Vietnam electricity Corporation is the State-owned

companies, have a direct function of producing, trading and financial investment in other businesses, retained the right to govern the subsidiary through which State property Affairs, management, technology, brands and markets.

- Article 2. Held: 1. The ministries, ministerial agencies, government agencies implement state management functions in the relevant fields and perform a number of rights and obligations of the owners that the prime delivery for electricity Vietnam.
- 2. The Department of industry is responsible for directing and monitoring the implementation of this decision; promptly discovered, solving these problems arise, reported the Prime Minister addressed the issue beyond the authority; hosted, in cooperation with related agencies to study, propose to Prime new

problems need to pilot in the implementation process.

3. The Secretary of the Ministry of finance, planning and investment, labor, invalids and Social Affairs; The heads of the agencies concerned, the Steering Committee and the business development functions, the mission is responsible, in coordination with the Ministry of industry and the Board Of the company electricity of Vietnam in the implementation of the tasks mentioned above. Article 3. This decision has the effect after 15 days from the date The report. The Secretary of the Ministry of industry, finance, planning and investment, labor, invalids and Social Affairs, heads of agencies, steering innovation and enterprise development and the Board Of the company electricity of Vietnam is responsible for the implementation of this decision.
