Decree No 91

On rates of custom duties on export-import operations in the Azerbaijan Republic

Baku, 22 April, 1998

According to Customs Code of the Azerbaijan Republic and Law of the Azerbaijan Republic «On customs tariff» and in order to increase the efficiency of foreign-economic relations, to create necessary terms for development of business activity, manufacturing of competitive production in the country and protection of inner market by further improvement of mechanism of custom tariffs, Cabinet of Ministers of the Azerbaijan Republic issues a decree:

- 1. To approve «Rates of customs duties, collected for customs clearance» submitted by State customs committee and agreed with involved organizations.
- 2. To keep the commodity classification of foreign-economic activity of the Azerbaijan Republic according to classification system, accepted in international practice.
- 3. To state that exported commodities irrespective of their kind are not subject to payment of export duty.
- 4. To state that according to article 33 of the Azerbaijan Republic «On customs tariff» the following commodities are not subject to import duty:
- 4.1 the property imported as a contribution of foreign investor to the partnership fund of joint venture or for establishment of venture, 100 % shares of which belong to foreign investor.
- 4.2 property (having submitted to customs authorities statement on cost and amount of investments to the Republic, and also about job executor) imported to the Azerbaijan Republic by foreign employees of enterprises with foreign investments solely for their own needs;
- 4.3 commodities, imported at the expense of gratuitous financial and technical assistance, grants, credits and loans and also share of Azerbaijan in projects fulfilled at the expense of these credits and loans, provided by international organizations, governments of foreign states, and also on the basis of interstate and intergovernmental agreements foreign legal entities and physical persons;
- 4.4 commodities, imported by physical persons as humanitarian aid intended for free distribution.
- 4.5. special technical devices, equipment, appliances, tools, component parts, spare parts, accessories and materials, exported on the basis of confirming document of the State Commission for Extraordinary Situations of Azerbaijan Republic to establish the logistics system, seismic observation points and rescue units and for their activity with the purpose of prevention and elimination of consequences of extraordinary situations.
- 4.6. operations on contribution of fixed capital stock, personal property and other assets to the State Petroleum Fund, transfer of which to the Azerbaijan Republic, including to its legal entities is stipulated on the basis of exploration, development and production sharing agreements of oil and gas resources, export pipe lines and other similar agreements.
- 4.7. passports and forms of identity cards of the citizens of Azerbaijan Republic, equipment, goods, accessories and materials, exported for their individualization, establishment and application of automated information-retrieval system "Entry-Exit", identification of finger-prints.
- 5. To state that with respect to commodities specified in the Supplement «On rates of import customs duties for commodities imported to the territory of the Azerbaijan Republic» of this Decree, irrespective of the country of

origin, import customs duties shall apply in accordance with codes of commodity nomenclature of foreign-trade activity; as for commodities not specified in this Supplement import customs duties shall apply in amount of 15 % of their customs value.

- 6. To state that in case of customs clearance of commodities, imported within the limits of states, governments and international organizations, legal and physical persons as humanitarian aid intended for free distribution, the humanitarian organizations importing these commodities should submit the document on duly registration at the territory of the Azerbaijan Republic to customs bodies, and other legal and physical persons permit of Republican commission on international humanitarian aid.
- 7. In cases when agreements of the Azerbaijan Republic on free trade and co-operation with foreign countries envisage mutual release from import customs duties, imported goods shall not be subject to payment of import customs duty.
- 8. To state that for free distribution of the commodities, specified in sub-clauses 4.1; 4.2; 4.3 and 4.4 of the present Decree, specified commodities should be re-declared and customs import duties should be paid as per them. Otherwise, the measures, envisaged by the legislation shall be taken as per persons, selling these commodities.

Implementation of this clause will be controlled by State Customs Committee, Ministry of Trade and State Tax Inspectorate, as for organisations financed from the state budget—by Ministry of Finances.

- 9. State customs committee and authorized banks should provide full and timely transfer of custom duties on import operations to the state budget.
- 10. Following this Decree State customs committee shall prepare relevant instructions, after agreement with the Ministry of finances, approve them and take necessary measures.
- 11. To regard decrees of the Cabinet of Ministers of the Azerbaijan Republic № 62, dated 16 June, 1997 (except clause 9) and № 79, dated 15 July, 1997, 5-st and 6-th paragraphs of clause 1 of Decree «On introduction of changes and amendments to some decrees of the Cabinet of Ministers of the Azerbaijan Republic» No 167 dated 5 August, 1998 and part 1 of clause 1 of Decree «On introduction of changes and amendments to some decrees of the Cabinet of Ministers of the Azerbaijan Republic» No 91 dated 22 April, 1998 null and void.
- 12. This decree comes into force from the moment of its signing.

Rates of customs duties, collected for customs clearance

1. For customs clearance of the commodities (including means of conveyance, transported over the customs border of the Azerbaijan Republic) including commodities and cargoes, and also means of conveyance not

intended for commercial purposes, transported in non-convoyed baggage and international postal sending is collected customs duty in the amount of 0,15 % of its customs cost (not less than 10 US dollars) in manats at rate of National Bank of the Azerbaijan Republic, and for export of profitable hydrocarbons related to the share of the Azerbaijan Republic on the basis of production sharing agreements between the State Oil Company of the Azerbaijan Republic and foreign oil companies by means of oil pipeline at rate 275 US dollars for each cargo customs declaration irrespective the cost of exported product.

- 2. Customs duties are not taken for customs clearance of the commodities and means of conveyance, transported over the customs border of the Azerbaijan Republic as financial support, humanitarian and technical aid, received as grant on the basis of agreement (decree) about grant and also for official use of diplomatic representations, located in the Azerbaijan Republic and private use of personnel of these representations, for mutual transfer of electric power.
- 3 For each additional sheet of customs cargo declaration irrespective of the type of deal payment shall be taken in the amount of 5 US dollars in manats at rate of National Bank Azerbaijan Republic.
- 4. For customs clearance of the commodities, transported over the customs border of the Azerbaijan Republic liable to custom regime of transit are collected customs duties in the amount of 30 US dollars, for each additional Transit cargo declaration 10 US dollars in manats at rate of National Bank of the Azerbaijan Republic.
- 5. For issue of the document on registration of transport means exported (including imported temporarily) to customs territory of the Azerbaijan Republic by physical persons is taken customs payment in the following amount:
 - for freight and automobile transport, minibuses and buses 20 US dollars;
 - for other transport means 15 US dollars. The payment is made in manats at rate of National Bank of the Azerbaijan Republic.
- 6. For registration of the commodities and transport means over working time of customs bodies of the Azerbaijan Republic and outside specified place are collected double customs duties.
