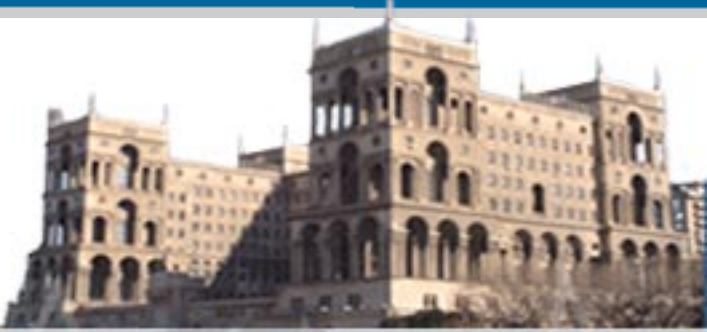

6.2.1.	Legal entities and individuals, regardless of their organizational and legal form, Azeristiliktechizat Open Joint-Stock Company and gas filling stations selling compressed natural gas (CNG) for the purpose of providing central heating and hot water to apartment buildings	165,0
6.2.2.	For use as a raw material in the production of methanol and urea products	200,0
6.2.3.	Industry and agriculture	220,0
6.2.4.	Other areas	250,0
7.	For the purposes of production of electricity sold within the country by direct connection to the main gas pipelines (except for consumers specified in paragraph 6 of this decision) (provided that the monthly consumption is not less than 10 million m ³)	165,0

Notes:

- Shall be determined that:
 - Wholesale tariff of natural gas determined in the 5th line of the table of the 1st paragraph of this resolution includes mine tax;
 - Tariffs determined in the 5th, 6th and 7th lines of the table of the 1st paragraph of this resolution cover all expenses connected with natural gas transportation.
