The following Act of Parliament received the assent of the President on the 31st March, 1973, and is hereby published for general information:

THE COAL MINES (TAKING OVER OF MANAGEMENT)  
ACT, 1973

25th December 1973

1214, March, 1973

An Act to provide for the taking over, in the public interest, of the management of coal mines, pending nationalisation of such mines with a view to ensuring rational and co-ordinated development of coal production and for promoting optimum utilisation of the coal resources consistent with the growing requirements of the country, and for matters connected therewith or incidental thereto.

Be it enacted by Parliament in the Twenty-fourth Year of the Republic of India as follows:—

## CHAPTER I

## Preliminary

1. (1) This Act shall be called the Coal Mines (Taking Over of Management) Act, 1973.

(2) It shall be deemed to have come into force on the 30th day of January, 1974, except so far as Part II of section 8 which shall come into force at once.

2. In this Act, unless the context otherwise requires,—

(a) "appointed day" means the 31st day of January, 1973;

(b) "coal mine" means a mine in which there exists one or more seams of coal;

(c) "company" means a company as defined in section 3 of the Companies Act, 1956, and includes a foreign company within the meaning of section 501 of that Act;

(d) "controller", in relation to a coal mine, means the person appointed under section 6 to take over, or carry on, the management of the coal mine;

(e) "Government company" has the meaning assigned to it by section 617 of the Companies Act, 1956;

(f) "managing contractor," means the person, or body of persons, who, with the previous consent in writing of the State Government, has entered into an arrangement, contract or understanding with the owner of the coal mine under which the operations of the mine are substantially controlled by such person or body of persons;

(g) "mine" means any excavation where any operation for the purpose of searching for or obtaining minerals has been or is being carried on, and it includes—

(i) all haulage and bore holes;

(ii) all drifts, whether in the course of being sunk or not;

(iii) all levels and inclined planes in the course of being driven;

(iv) all open cast workings;

(v) all conveyors, or other transportways provided for the bringing into or removal from a mine of mineral, or other articles, or for the removal of refuse, threfrom;

(vi) all roads, buildings, works, galleries, levels, mines, machinery and equipment, instruments, store vehicles, railways, tramways and sidings under, adjacent to, a mine and used for the purposes of the mine;

(vii) all workshops, including buildings, machinery, instruments, stores, equipment, of such workshops and the lands on which such workshops stand in, or adjacent to, a mine and used substantially for the purposes of the mine or a number of mines under the same management;

(viii) all coal in stock or in transit belonging to the owner of the mine and all coal under his control in a mine;

(ix) all power stations in a mine or operated primarily for supplying electricity for the purpose of working the mine or a number of mines under the same management;

(x) all buildings, and improvements, belonging to the owner of the mine, and in adjacent to or situated on the surface of, the mine where the washing of coal obtained from the mine or manufacture, the sorting of coal is carried out;

(v) all land and buildings (other than those referred to in sub-clause (iv)) wherever situated and solely used for the location of the management, sale or labour offices, or for the residence of officers and staff, of the mine;

(vi) all other assets, movable and immovable, belonging to the owner of a mine, wherever situated, including cash balances, reserve funds and investments, so far as they relate to the mine and also any money lawfully due to him in relation to the mine or is spent at any period prior to the appointed day;

(ii) "mining company" means a company owning a coal mine, and in relation to a particular mine, carries within the meaning of section 2(1) of the Companies Act, 1956, the shareholders of that company in India;

(iii) "notified order" means an order notified in the Official Gazette;

(iv) words and expressions used herein and not defined but defined in the Coal Mines (Conservation, Safety and Development) Act, 1952, have the meanings, respectively, assigned to them in that Act;

(v) words and expressions used herein and not defined in this Act or in the Coal Mines (Conservation, Safety and Development) Act, 1952, have the meaning, respectively, assigned to them in the Mines Act, 1952.

## CHAPTER II

### Management of coal mines

3. (1) On and from the appointed day, the management of all coal mines shall vest in the Central Government.

(2) Without prejudice to the generality of the provisions of sub-section (1), the coal mines specified in the Schedule shall be deemed, for the purposes of this Act, to be coal mines the management of which shall vest, under sub-section (1), in the Central Government:

Provided that if, after the appointed day, the existence of any other coal mine comes to the knowledge of the Central Government, whether after an investigation or in pursuance of an intimation given to it under subsection (3), or otherwise, the Central Government shall, by a notified order, make a declaration about the existence of such mine, and on and from the date of such declaration—

(i) the management of such coal mine shall be deemed, for the purposes of this Act, to vest in the Central Government; and

(ii) such coal mine shall be deemed to be included in the Schedule;

and thereupon the provisions of this Act shall become applicable thereto subject to the modification that for the word "appointed day", wherever occurring, the words, brackets and figures "date of the declaration made by the Central Government under sub-section (2) of section 3" shall be substituted.

(3) If any error or omission is found in the Schedule in relation to the name or address of the owner of a coal mine, the owner of such mine shall, within thirty days from the date on which this Act receives the assent of the President, bring such error or omission to the notice of the Central Government.

Management of coal mines to vest in the Central Government on the appointed day.

(g) If, after the appointed day, the Central Government is satisfied, whether from any information received by it or otherwise, that there has been, by error, omission or description in relation to the particulars of a coal mine included, or deemed to be included, in the Schedule or the name and address of the owner of any such coal mine, it may, by notification, correct such error, omission or misdescription, and on the issue of such notification the relevant entries in the Schedule shall stand corrected accordingly:

Provided that no such correction in relation to the ownership of a coal mine shall be made where such ownership is in dispute.

(h) Every person in charge, immediately before the date on which this Act receives the assent of the President, of the management of any coal mine, being a coal mine not included or deemed to be included on the said date in the Schedule, shall, within thirty days from the said date, inform to the Central Government the name and location of such mine and the name and address of the owner thereof.

(i) Where there is a dispute, with regard to the derivation made by the Coal Board under the Coal Mines (Emergency Provisions) Act, 1971, to the effect that a coal mine contains coking coal, the management of such coal mine shall, within twenty-four hours of the coming into force of this Act, vest in the Central Government under this Act and nothing contained in the abovespecified Act shall apply, or be deemed ever to have applied, to the said coal mine.

4. Any contract, whether express or implied, providing for the management of any coal mine, made before the appointed day between the owner of such mine and any person in charge of the management of such mine immediately before the appointed day shall be deemed to have terminated on the appointed day.

5. (1) Pending the appointment of a Custodian under section 6 for any coal mine, the person in charge of the management of such mine immediately before the appointed day shall, on and from the appointed day, be in charge of the management of such mine for and on behalf of the Central Government; and the management of such mine shall be carried on by such person subject to the provisions contained in subsections (2) and (3) and other directions, if any, as the Central Government may give to him and for this purpose, awaiting the owner, shall, so long as such management continues, exercise any powers of management in relation to the coal mine in accordance with regard to such management.

(2) No person in charge of the management of a coal mine shall, without the previous approval of the person specified by the Central Government in this behalf in respect of that mine (hereinafter referred to as the "authorised person")—

(a) incur any expenditure from the moneys pertaining to the coal mine other than for the purpose of making regular payments of salaries or remunerations to the labour, agents or for the purpose of meeting the usual due-diligent expenditure;

(b) transfer or otherwise dispose of any such moneys or create any charge, hypothecate, let or other encumbrance thereon;

(vi) A statement of any contract or agreement forming part of such assets, specifying the term and the period, and of the amounts forming part thereof.

(vii) Every information, contract or service or agency, whether given by or by appointment, or otherwise received wholly or partly with the coal mine or with the lessee, and corrections of any such contract abounding on the appointed day;

(viii) And any other transaction relating to the business of the coal mine or with the terms of any agreement relating to such business existing at the commencement of this Act;

(ix) The approval of the authority given or may be given either generally in relation to certain classes of transactions relating to the coal mine or specially in relation to any of its transactions;

(x) Every person in charge of the management of a coal mine shall deposit all securities and documents of title to any assets pertaining to such mine at any branch or outlet of Nationalized Bank on which the owner or agent has his account standing before the appointed day or at any branch of the State Bank in the place where the head office or the principal office of the coal mine is situated or where there is no branch of the State Bank in such place, the nearest branch of the State Bank; and immediately on such deposit shall be withdrawn from the Scheduled Bank, the amount equivalent to the value of the assets, except under the permission of the authorized person.

Provided that nothing contained in this subsection shall apply to any security or document of title except in trust with a Others, Trustee in Possession or the articles of incorporation of any mining company under the Central Government, by notified order, otherwise directs.

**Definitions.** In this section, namely:

(i) "Scheduled Bank" means a bank induced for the time being in the Second Schedule to the Reserve Bank of India Act, 1934;

(ii) "State Bank" means the State Bank of India constituted under the State Bank of India Act, 1934;

(iii) "Nationalized Bank" means a corresponding new bank as defined in the Banking Companies (Acquisition and Transfer of Undisbursed Advances) Act, 1960.

(iv) Every person in charge of the management of a coal mine shall deliver to or cause to be delivered to the authority mentioned in the appointed day the following documents, namely:-

(a) The mutual books or any other book or List containing all the details up to the appointed day, of the persons in charge of the management of the coal mine before the appointed day;

(b) The cheques issued by the coal mine, which are at any time of the writing;

(c) All receipts and bills or the containing particulars relating to the fixing of or increasing price him, to the coal mine including rents, all costs of labour, and all form printed or otherwise made;

(d) Without prejudice to the generality of the powers conferred by subsection (7) and the power mentioned in subsections (2), (3) and (5), any directions issued under subsection (1) may require the persons

in charge of the management of a coal mine under this Act to furnish to the Central Government or to the authorised person such returns, statements and other information relating to the coal mine as may be mentioned in the direction.

(7) The persons in charge of the management of the coal mine under this Act shall be entitled to such remuneration, whether by way of allowance or salary or perquisites as the Central Government may fix; and any such person may, by giving one month's notice in writing to the Central Government of his intention so to do, relinquish charge of the management of the coal mine.

(8) (1) The Central Government may, as soon as it is convenient administratively so to do, appoint any person (including a Government company, whether in existence at the commencement of this Act or incorporated thereafter) as the Custodian for the purpose of taking over the management of one or more coal mines and the person so appointed shall carry on the management of such mine, for and on behalf of the Central Government.

(2) (a) The Central Government may also appoint a person (including a Government company, whether in existence at the commencement of this Act or incorporated thereafter) as the Custodian-General for exercising supervision and control over all the coal mines the management of which is taken over under the Act and on such appointment, every Custodian appointed under clause (1), shall act under the guidance, control and supervision of the Custodian-General.

(b) The Central Government may also appoint one or more persons as Additional Custodian-General or Deputy Custodian-General for assisting the Custodian-General in the exercise of his powers and duties under this Act and the Custodian-General may delegate all or such of his powers, as he may think fit, to the Additional Custodian-General or Deputy Custodian-General.

(c) Every Additional Custodian-General or Deputy Custodian-General shall exercise the powers delegated to him under the control and supervision of the Custodian-General.

Provided that where a Government company has been appointed as the Custodian in relation to a coal mine, the Custodian-General, Additional Custodian-General or Deputy Custodian-General shall exercise any powers of supervision or control in regard to such coal mine.

(3) On the appointment of a Custodian under subsection (1), the charge of management of the coal mine shall rest in him and all persons in charge of the management of such mine immediately before such appointment shall cease to be in charge of such management and shall be bound to deliver to the Custodian all assets, books of account, registers or other documents in their custody relating to the coal mine.

(4) Notwithstanding any judgment, decree or order of any Court or anything contained in any other law for the time being in force, the Official Liquidator or any Receiver appointed by any Court or any other person who has, on the appointed day, in his possession, custody or control any coal mine specified in the Schedule or any part thereof, shall forthwith deliver possession of the mine or such part thereof, as the case may be, to the Custodian.

(5) The Official Liquidator, Receiver or any other person who has, on the appointed day, in his possession, custody or control any books, docu-

units or other papers relating to any coal mine specified in the Schedule, shall be liable to account to the said bodies, documents or other papers to the Central Government and it shall deliver them up to the Custodian or to such person as the Custodian may specify in this behalf.

(g) The Central Government may authorise the Custodian to exercise such of the powers of the owner, including power to borrow, as may be necessary for the proper management of the coal mine and the Central Government may also issue such directions to the Custodian as to his powers and duties so it may deem desirable in the circumstances of the case, and no other person, including the owner, shall, so long as such management continues, exercise any powers of management in relation to the coal mine or give any direction with regard to such management.

(h) The Custodian may also apply to the Central Government at any time for instructions as to the manner in which he shall conduct the management of the coal mine or in relation to any other matter arising in the course of such management.

(i) The Custodian will receive from the owner of the coal mine for the eligible amount, payment of a lump sum payment under subsection (H), such remuneration as the Central Government may fix.

Provided that where a Government company has been appointed as the Custodian of more than one coal mine, the remuneration of the Custodian shall be received from the funds of each coal mine in such proportion as may be fixed by and by the Central Government.

(j) The Custodian shall stand ex-officio—

- (i) Additional Collector-General,
- (ii) Deputy Collector-General,
- (iii) Custodian

shall hold office during the pleasure of the Central Government.

(k) The Central Government shall exercise to the exclusion of all other persons, any rights due to the coal mine realised after the appointed due date of settling that will receipt pertains to a transaction made at any time before the expiry of 2 days.

7. (1) Every receipt of coal to be sold will be given by the Central Government or agent in coal for the settling in it under section 3 of the agreement of sale of coal.

(2) For every month can establish the management of a coal mine remains less than the Central Government, the amount referred to in paragraph (1) shall be computed at the rate of twenty per centum for each ton of the highest monthly production of coal from each mine during the month in the years 1969, 1970, 1971 and 1972.

Provided that if the operator of the coal mine, the owner or his brother or relative or the husband or the wife of referred to in sub-section (1) shall be computed at the rate of four point per centum of each fifteen monthly coal in the month of the coal mine before the amount of day as may be fixed and declared by the Coal Board.

Provided further that in addition to pay rent, the operators of which were more likely before the appointed day under the contract of a mining contractor, the amount as computed under this subsection, shall be mentioned to the owner of the coal mine and such mining contractor in writing in terms as may be agreed upon by or between the owner and such contractor and in the event of there being no such agreement, in such way as may be determined by the principal

Chief Coal Inspector to make a deduction of such value  
from the fees of the coal mine, the amount of which shall  
determine the fees of the coal mine.

(3) The amount of deduction to be made by the chief  
Coal Inspector from the fees of the coal mine, remains varied in  
the Central Government under this Act, shall be fixed by the  
Central Government at such a liability to the amount referred to in sub-  
section (1), to the number of coal miners owned, at an amount computed  
at the rate of fifty paise per tonne of coal on the highest monthly pro-  
duction of coal for each of the eight days during any month in the years  
1963, 1964, 1965 and 1966.

(4) Out of the amount varied under the former sub-section, there  
shall be deducted like the sum of 4/- amount all sums equal to the  
amount of arrears due on the eight days to the persons employed  
by the owner of a coal mine, and

(5) In relation to the existing fund, new or fund, gratuity, and/or  
any other fund of 1/-, 1/-, 1/-, the amount of the persons employed by  
the owner of the coal mine, and

(6) as wages.

(7) All amounts deducted under sub-section (4) shall, in accordance with  
sub-section (1), be paid under this Act to be credited by the Central  
Government to the account for loan paid by that Government to the  
persons to whom the said amounts are due, and on such credit or payment,  
the liability of the owner in respect of the amount of arrears due to above  
and shall, to the extent of such credit or payment stand discharged.

## CHAPTER II.

### THE OFFICER.

Permitted.

#### 8. (1) If any person—

(a) fails to deliver to the Chief Coal Mine Inspector, his account,  
registers or any other document in his custody relating to the coal  
mine in respect of the amount of which the Inspector has been  
appointed, or

(b) retains any property of such coal mine or removes or destroys  
it, or

(c) fails to comply with the provisions contained in subsection  
(9) or subsection (10) or section (5) of section five,

(d) fails to comply with any direction given under sub-section  
(1), read with subsection (6), of section five,

he shall be liable to the sum or any amount not less than which may extend  
to two years, or with fine which may extend to ten thousand rupees, or  
with both.

(2) If any person fails, without any reasonable excuse, to comply with  
the provisions of sub-section (5) of section 8, he shall be punished with  
imprisonment for a term which may extend to three years and also with  
fine.

9. (1) Where an offence under this Act is being committed by a com-  
pany every person who, at the time the offence was committed was in  
charge of, and every person who, at the time the offence was committed, was in  
charge of, the company, as well as the company, shall be deemed to be  
guilty of the offence and shall be liable to the punishment aforesaid, and  
punished accordingly.

Provided that no such order or direction as aforesaid under any such section made to any person shall stand if it is proved that the offence was committed with intent to defraud or that he had exercised all due diligence to prevent the commission of such an offence.

(2) Notwithstanding anything contained in sub-section (1), where any offence under this Act has been committed by a company and it is proved that the offence has been committed with the consent or connivance of, or is attributable to, any neglect on the part of, any director, managing agent, secretary or other officer of the company, such director, managing agent, secretary or other officer shall be deemed to be guilty of that offence and shall be liable to a proceeding against and punished accordingly.

*Explanation.—* For the purposes of this section—

(1) "Managing agent" means any person who, whether or not he is a director, is employed by a company to manage its business.

(2) "Secretary" includes manager, managing partner in the firm.

(3) No proceeding for the winding up of a company, the management of whose business is entrusted to the Central Government under this Act, or for the appointment of a Receiver or for any other order or report of the business of such company, shall be in any Court except with the consent of the Central Government.

(2) Notwithstanding anything contained in the Companies Act, 1956, or in any instrument amending or modifying any existing company or in any instrument, or resolution passed at any meeting of the Board of Directors, if the members of a company so resolve, in so far as it relates to the said members, to such company or any subscribers of such shares, be given effect to under any law made by the Central Government.

(3) Subject to the other provisions contained in the Act and subject to such exceptions, restrictions and limitations, if any, as the Central Government may, by resolution made in the Central Government, specify in this behalf, the provisions of Part III of the Companies Act shall apply to every company in Part II and to any other company formed before the appointed day.

(4) In respect of the said Part III, any power granted by any law for the trial of persons for any offence against any person by the members of a company, or any power given by any instrument of incorporation or by any other instrument, to any court or tribunal which the Act purports to amend, shall be construed

(2) The provisions of this Act shall have effect notwithstanding that inconsistent rules were contained in any other law for the time being in force or in any instrument having effect by virtue of any law other than this Act, or in any decree or order of any Court, tribunal or other authority.

(3) If the Central Government may, by a ruled order, direct that all or any of the powers expressly given by this Act may also be exercised by any person or persons whom may be specified in the order.

11. (1) No suit, prosecution or other legal proceeding shall be against the Custodian-General, Additional Custodian-General, Deputy Custodian-General, any Custodian or authorized person for anything which is in good faith done or intended to be done under this Act.

(2) No suit or other legal proceeding shall be against the Central Government or the Custodian-General, Additional Custodian-General, Deputy Custodian-General, any Custodian or authorized person for any damage caused or likely to be caused by anything which is in good faith done or intended to be done under this Act.

15. (1) Every person with whom the owner or lessee of any coal mine has, before the date on which he entered into any contract for any service, place than a written copy of implement, file or supply shall, within fifteen days from the date on which this Act receives the assent of the President, intimate to the Central Government the particulars of such contract and if any default is made in giving such information such contract shall, on the expiry of the said period of fifteen days, be voidable at the option of the Central Government.

(2) If the Central Government is satisfied after such inquiry as it may think fit that any contract or agreement between the owner, agent or manager of a coal mine and any other person, in so far as such contract or agreement relates to the coal mine, has been entered into to the detriment of the interests of the coal mine, it may make or issue an order cancelling or varying (either unconditionally or subject to such conditions as it may think fit to impose) such contract or agreement and the effect the contract or agreement shall have effect accordingly.

Provided that no order so made shall be cancelled or varied except with regard to the parts of the contract or agreement a reasonable opportunity of being heard.

16. Any person who contravenes an order made under subsection (2) may be imprisoned for a term of three years and fined within the sum of Rs. 1000 or where the amount involved in the contravention of the said mine is more than Rs. 1000 the maximum term of imprisonment shall be ten years and the maximum fine shall be double such amount.

16. In the event of any person who is in charge of employment of any coal mine or any other officer of the State, failing to give notice before the expiry of the period mentioned in the order that it is necessary to do so, or if the deposit of the wages of any servant of a coal mine, be unpaid, by virtue of the power contained in the order his notice in writing or the salary or wage for one month or less than one month terminate such contract of employment.

17. (1) The Central Government may, by notification in the Official Gazette, make rules to carry out the purposes of this Act.

(2) In particular and without prejudice to the generality of the powers hereinabove contained, such rules may provide for all or any of the following matters, namely—

(a) the manner in which the coal mines shall be managed by the Central Government;

(v) the constitution of a Board or managing body, by whatever name called, for securing the Coal-mines General interest of the coal-mines;

(c) the future modification of which would not affect the coal-mines and be maintained;

(d) any other matter in relation to which such rule is required to be, or may be, made.

(e) Every rule made by the Central Government under this Act shall be laid, as soon as may be after it is made, before each House of Parliament, while it is in session, for a total period of thirty days which may be comprised in one session or in two or more successive sessions, and it, before the expiry of the session immediately following the session or the second session aforesaid, either House may, in making any resolution that the rule or regulation agreed that the rule should not be made, the rule shall thereafter have effect only in such modified form or be of no effect, as the case may be; and, however, that any such regulation or arrangement shall be without prejudice to the validity of anything previously done under that rule.

18. (1) Notwithstanding anything to the contrary contained in this Act,

(a) owned, managed or controlled by the Government, or by a Government company or by a company which is owned, managed or controlled by the Government;

(b) owned, managed or controlled by a company engaged in the production of iron and steel;

Provided that clause (b) shall not extend to such part of the coal mine or production thereof taken, in the opinion of the Central Government, to be excess of the requirements for the production of iron and steel by the company owning, or managing, such coal mine;

Provided further that any coal owner or manager of such coal mine as is referred to in the foregoing provision may, save if the requirements for the production of iron and steel by the company owning or managing such coal mine, shall not be sold, destroyed, transferred or otherwise disposed of except with the previous approval of the Central Government;

(2) Subject to (1) and notwithstanding anything to the contrary contained in the mining rights issued by the Government, Government company or corporation referred to in clause (a) of that subsection, no company referred to in clause (b) of that subsection shall, in respect of any coal mine or any part thereof, acquire, sell, withhold, or dispose of, property which is in such coal mine or is used for the purpose of such coal mine.

19. If any difficulty arises in respect of the operation of this Act, the Central Government may, by written Order, not inconsistent with the provisions of this Act, remove the difficulty:

Provided that such an order shall be made after the expiry of a period of two years from the appointed day.

20. (1) The Coal Mines (Taking Over of Management) Ordinance, 1973, is hereby repealed.

(2) Notwithstanding such repeal, anything done or any action taken under the Ordinance or repeated (regularly, but independently, subsequently or otherwise thereto), shall be deemed to have been done or taken under the corresponding provisions of this Act.
